

Overview of the Industry



- The global food and beverages industry is made up of many segments, including groceries, oils and fats, food additives, functional foods and beverages, packaged foods, health and natural foods, canned food, baked food, baby food, animal food, soft drinks, alcoholic drinks, energy drinks, and packaging.
- The industry is driven by consumer demand for more nutritious food and better packaging, which also spurs technology advances in the field. Today, pasteurization, high-pressure processing, UV treatment, and nanotechnology are influencing the industry. A concern for the environment has led to the use of more recycled material for packaging.
- The growth of the food and beverages industry is propelled mainly by developing countries such as India, China, and Brazil, as the economies of these nations improve, and more people are lifted into the middle class.
- The global food, beverage, and grocery industry was estimated to be worth \$7.8 trillion in 2015, or about 10 percent of the world GDP, according to Plunkett Research. The global packaged-food industry was worth \$2.5 trillion. In 2013, global food exports added up to \$1.43 trillion.
- By market size, the top ten countries for the overall food and beverages (grocery) industry are the US (about \$1.7 trillion, according to approximations from various sources), China (\$700 billion), Japan (\$600 billion), India (\$400 billion), Russia (\$350 billion), Brazil (\$250 billion), Germany (\$225 billion), France (\$200 billion), UK (\$180 billion), and Indonesia (\$175 billion).

India is expected to become the fifth largest consumer market in the world by 2025, according to a paper prepared by the Confederation of Indian Industry (CII) and Grant Thornton. Food and beverages is the biggest of the consumption categories. The F&B sector is supported by the vast agriculture sector: India is the biggest producer of pulses, and the second biggest producer of rice, wheat, sugarcane, and fruits and vegetables. It is also the biggest producer of milk and buffalo meat and ranks fifth in poultry production.

Requirements for Registration/ License of Food businesses

FSSAI Registration	FSSAI State License	FSSAI Central License
This is required for small business or all businesses or Start- Ups. Eligibility criteria is as follows for different kind of businesses. with an annual turnover not exceeding Rs. 12 lakhs and/or whose production capacity of food (other than milk and milk products and meat and meat products) does not exceed 100 kg/litres per day or procurement or handling and collection of milk is up to 500 litres of milk per day or slaughtering capacity is 2 large animals or 10 small animals or 50 poultry birds per day or less	This is required for mid sized companies Eligibility criteria is as follows for different kind of businesses. with an annual turnover between Rs. 12 lakhs to 20 crores production capacity of food (other than milk and milk products and meat and meat products) does not exceed 500 kg/litres per day or procurement or handling and collection of milk is up to 5000 litres of milk per day or slaughtering capacity is between 2-50 large animals or 10-150 small animals or 50-1000 poultry birds per day	This is required for large businesses. Eligibility criteria are as follows With an turn over above Rs 20 Crores Dairy units including milk chilling units equipped to handle or process more than 50,000 litres of liquid milk/day or 2500 MT of milk solid per annum. Vegetable oil processing units and units producing vegetable oil and refineries including oil expeller unit having installed capacity more than 2 MT per day. All slaughter houses equipped to slaughter more than 50 large animals or 150 or more small animals including sheep and goats or 1000 or more poultry birds per day. Meat processing units equipped to handle or process more than 500 kg of meat per day or 150 MT per annum.

- **FDI POLICY** 100 % FDI under government approval route for, trading, including through e-Commerce for Food Products produced and manufactured in India.
- FISCAL INCENTIVE- 100 % Income tax exemption to food processing, units on profits for the first five years of operation and 25 % thereafter for the next 5 years. Pasteurizing, drying, evaporating, etc. machinery used in Dairy Sector is exempted from Excise Duty. Excise duty Refrigerated containers from 12.5% to 6%. Custome duty reduction in cold storage related items in Budget 2016-17.
- MEGA FOOD PARK- Government giving grand aid up to 75% on the basis of the general area or a difficult area to set up Mega Food Park.
- **SPECIAL FUND IN NABARD** To provide loans up to seven years, they have accumulated Rs.2000 crore of the fund to NABARD for food processing units.



Above are the few examples, such hundreds of arrangements are being done by Government to strengthen food Industries in India, thus definitely, the future is very bright and not only these are the only reason, but the cause behind the bright future of Food Industry is also:

- Growing populations and their vast demand for food
- Government policies like, 'Make in India', 'Startup India'

According to research by the India Brand Equity Foundation, the spending capacity of the Indian middle class is anticipated to double by 2025.
